§19-145-1 Purpose. The purpose of this chapter is to ensure that the State complies with the Federal Hazardous Materials Regulations. [Eff 3/30/87; am 1/11/88; am 1/20/89; am and comp 12/8/90; am and comp 11/29/93; am and comp 8/5/04; am and comp 12/4/09; comp 12/23/13; comp **SEP 24 2016** ] (Auth: HRS §286-202, 286-222, 286-223) (Imp: 49 CFR Parts 107, 171-173, 177, 178, and 180)

§19-145-2 Definitions. Unless the context clearly indicates otherwise, as used in this chapter: "Director" means the director of the state department of transportation.

"Hazardous Materials Regulations" means Title 49, Code of Federal Regulations, Parts 107, 171-173, 177, 178, and 180.

"State" means State of Hawaii. [Eff and comp 12/4/09; comp 12/23/13; comp **SEP 24 2016** ] (Auth: HRS §286-202) (Imp: 49 CFR Parts 107, 171-173, 177, 178, and 180)

§19-145-3 Authority. The director is authorized by section 286-202, Hawaii Revised Statutes, to adopt the Hazardous Materials Regulations. [Eff and comp 12/4/09; comp 12/23/13; comp **SEP 24 2016** ] (Auth: HRS §286-202) (Imp: HRS §286-202)

§19-145-4 Incorporation by reference. The Hazardous Materials Regulations, as they existed on November 1, 2015, are hereby adopted and incorporated into this chapter. [Eff and comp 12/4/09; am and comp 12/23/13; am and comp **SEP 24 2016**] (Auth: HRS §286-202) (Imp: 49 CFR Parts 107, 171-173, 177, 178, and 180)
