Hawaiian Airlines, Inc. (Hawaiian Airlines), whose business address is

CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 1519, dated July 17, 1952, setting aside 550.881 acres being a portion of General Lyman Field under the control and management of the Hawaii Aeronautics Commission [subsequently transferred to the Hawaii Department of Transportation (HDOT)] as a site for the Hilo Airport, now known as ITO.

CHARACTER OF USE:

Hawaiian Airlines will use the spaces for vehicle ramp parking for its Tech and Airport Operations team vehicles as part of its Signatory Airline Carrier operations at ITO.

COMMENCEMENT DATE:

To be determined by the Director of Transportation at a later date.

MONTHLY RENTAL:

\$1,890.28 (based on the rate of \$70.01 per square foot per annum for terminal space as determined from the HDOT Schedule of Rates and Charges established by appraisal of Airport property statewide).

SECURITY DEPOSIT:

\$5,670.84, or three times the monthly rental in effect.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The HDOT has determined that the subject areas are covered by the Hilo International Airport Final Environmental Assessment (FEA), dated April 15, 2003, and published by the Office of Environmental Quality Control in the May 8, 2003 issue of The Environmental Notice. Accordingly, all relevant mitigation from the FEA and best management practices will be implemented to address the minimum impacts of this action.

REMARKS:

The HDOT proposes to issue a month-to-month revocable permit to Hawaiian Airlines for vehicle ramp parking as part of its Signatory Airline Carrier operations at ITO.

RECOMMENDATION:

Based on this submittal, and testimony and facts presented, the HDOT recommends the Director of Transportation finds that approving the issuance of a month-to-month revocable permit to Hawaiian Airlines, including its conditions and rent, will serve the best interests of the State.

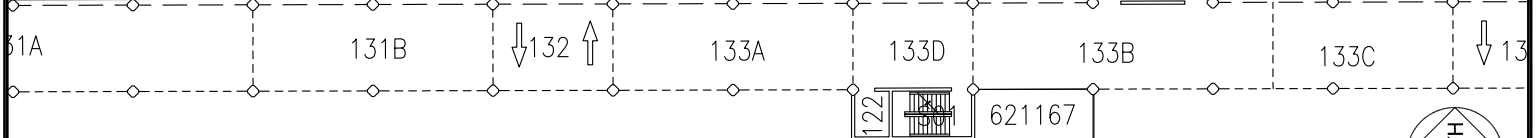
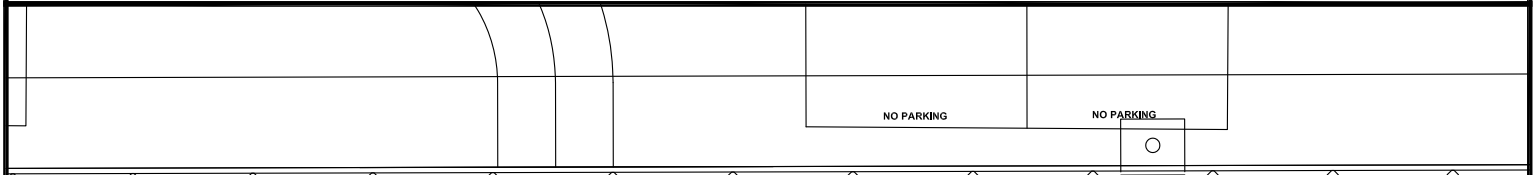
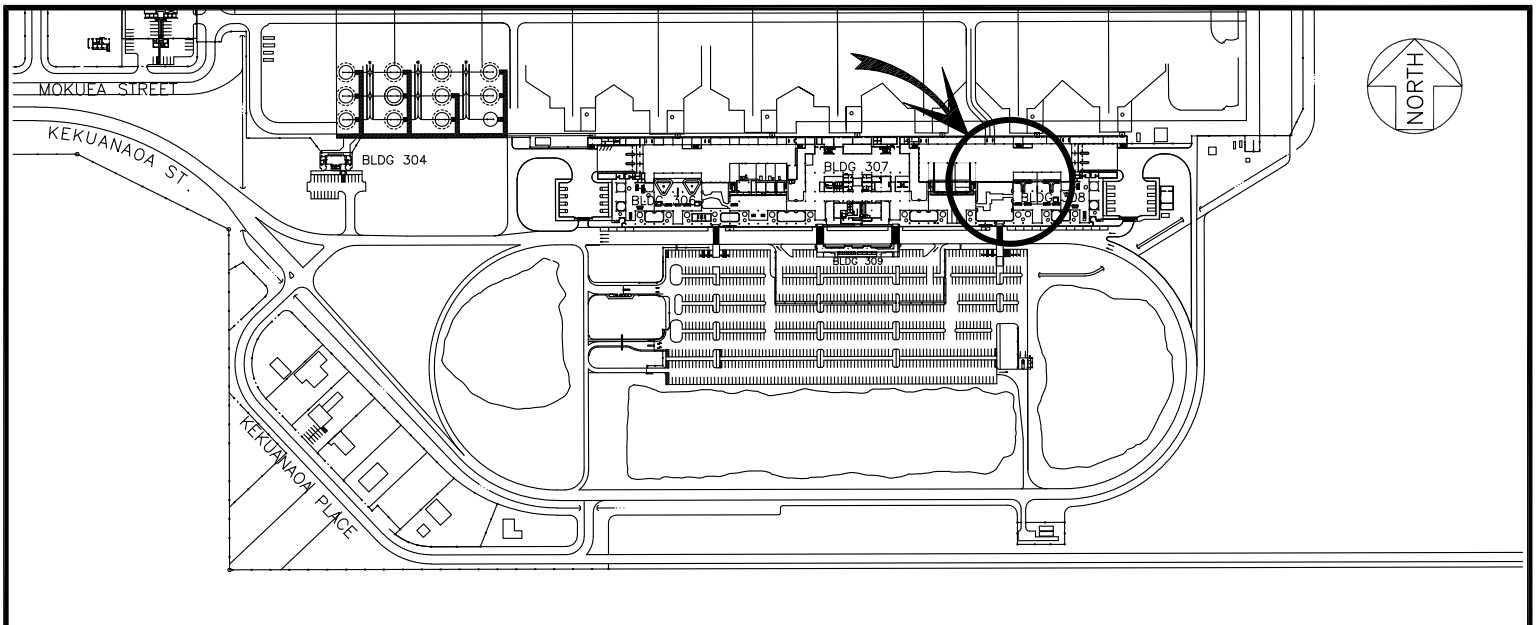
