# **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 2427, dated February 12, 1969, setting aside 1,268.938 acres designated as Kahului Airport to be under the control and management of the State of Hawaii Department of Transportation (HDOT) for public purposes.

# **CHARACTER OF USE:**

Primo will use the space for storage to support its pre-arranged transportation service operations.

# **COMMENCEMENT DATE:**

To be determined by the Director of Transportation at a later date.

#### MONTHLY RENTAL:

\$147.96 (\$118.80, based on a rate of \$26.40 per square foot per annum, as determined from the HDOT Schedule of Rates and Charges established by appraisal of Airports property statewide, plus \$21.06 for utilities and \$8.10 for maintenance).
