#### **HAWAII**:

Sale of portions of Old Volcano Road (OVR)

## REQUEST:

To approve the sale of portions of OVR to three (3) abutting owners, as shown on the attached Exhibit A. The three abutting owners are:

Mr. Monte Anderson – Tax Map Key (TMK) (3) 1-8-002:059 (Remnant Parcel 9C)

Mr. J. Blaise Caldeira/Ms. Pamela P. Caldeira - TMK (3) 1-8-002:044 (Remnant Parcel 9D)

The Roman Catholic Church - TMK (3) 1-8-002:006 (Remnant Parcel 9E)

#### LEGAL REFERENCE:

Hawaii Revised Statutes (HRS), Section 171-52 and other applicable sections of Chapter 171, as amended.

#### **LOCATION:**

The parcels are located on the island of Hawaii in the Puna district. The parcels are a part of the OVR which was an old government road. OVR runs parallel to the abutting State of Hawaii, Department of Transportation (HDOT) highway, Volcano Road. OVR is being used as an unpaved access road for the abutting properties to access Volcano Road. HDOT does not

maintain OVR. The portions being sold are not needed for the maintenance and operation of Volcano Road. Therefore, it is surplus to HDOT's needs. Our office has determined that no properties will be land locked due to the sale of these parcels. Please note that a five-foot easement will also be added to Remnant Parcel 9C to ensure access for the neighboring property will be maintained.

#### AREA:

Parcel 9C: 1,804 square feet

Parcel 9D: 3,928 square feet

Parcel 9E: 16,085 square feet

#### ZONING:

TMK No. (3) 1-8-002: 006, 044 and 059 are zoned "RS-20" for urban use.

#### **LAND TITLE STATUS:**

A 106 square foot portion of Remnant Parcel 9E is ceded.

The remainder of Parcel 9E as well as the entirety of Remnant Parcels 9C and 9D are non-ceded.

#### **CURRENT USE STATUS:**

Remnant Parcels 9C, 9D and 9E are being used as unpaved access roads from Volcano Road to the abutting properties for access.

#### CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

Not Applicable. The parcels were State owned lands that will become privately owned land upon transfer. HRS, Chapter 343 would not apply to any future development on the parcels as no State lands would be involved.

## **REMARKS**:

The parcels were deemed surplus to HDOT's needs. Our district office and engineering branches have no objections to the disposal and transfer to the abutting owners. We have attached the parcel map, TMK Map, site photos and cursory title search for the referenced parcels.

## **RECOMMENDATION:**







#### AS TO PARCEL 9-A (1017 SQUARE FEET):

By Warranty Deed, dated October 8, 1951, recorded October 19, 1951 in Liber 2511, Pages 405-412, by Olaa Sugar Company, Limited, an Hawaiian corporation to TERRITORY OF HAWAII, PARCEL 9-A, portion of Lot 109 of the Olaa Reservation Lots, being also a portion of Grant 4053 (metes and bounds description), area of 1,017 square feet or 0.023 acre.

# AS TO PARCEL 9-B (106 SQUARE FEET OR 0.002 ACRE) AND PORTION OF OLD VOLCANO ROAD:
