#### APPLICANT:

MKK Grab N Fly LLC, whose business and mailing address is P.O. Box 1280, Kaunakakai, Hawaii 96748.

# **LEGAL REFERENCE**:

#### LOCATION AND TAX MAP KEY:

#### **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 1611, dated February 1, 1954, setting aside 10,321 acres, being a portion of MKK under the control and management of the Hawaii Aeronautics Commission [subsequently transferred to the State of Hawaii Department of Transportation (HDOT)], for Airport purposes.

#### **CHARACTER OF USE:**

MKK Grab N Fly LLC will use the concession space to sell food, beverage and souvenirs.

#### **COMMENCEMENT DATE:**

To be determined by the Director of Transportation at a later date.

#### **MONTHLY RENTAL**:

\$1,284.66 (\$1,070.55 or six percent of the monthly gross receipts, whichever amount is greater, plus a fixed utility fee of \$214.11, as outlined in the HDOT Schedule of Rates and Charges).

#### SECURITY DEPOSIT:

\$3,853.98, or three times the monthly rental in effect.

#### CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:
