

PUBLIC INFORMATIONAL MEETINGS AT NEIGHBOR ISLAND AIRPORTS

The State of Hawai‘i, Department of Transportation, Airports Division (DOTA) is conducting a series of public informational meeting regarding the Rates and Charges for Non-Signatory Commercial Air Carriers.

The public informational meetings will be held at the airport district offices on the following dates and times:

Kona International Airport at Keahole on Thursday, June 16, 2016 at 5 p.m.
Hilo International Airport on Friday, June 17, 2016 at 6 p.m.
Kahului Airport on Monday, June 20, 2016 at 6 p.m.
Lihu‘e Airport on Tuesday, June 21, 2016 at 6 p.m.

Non-signatory Commercial Air Carriers are entities that are not signatory to the 2007 First Amended Lease Extension Agreement.

Non-signatory Commercial Air Carriers are entities that provide air transportation of passengers or cargo (1) operating under Federal Aviation Regulations (FAR) Part 121 or Part 129, or (2) providing scheduled air transportation with a frequency of at least five round trips per week on at least one route between two or more points according to published flight schedules and operating under FAR Part 135.

The purpose of the meeting is to discuss the rates and charges the DOTA plans to apply to Non-signatory Commercial Air Carriers.

The schedule of the proposed rates and charges is shown below.
