ORDER FOR EXEMPT PERSONS

Pursuant to the Governor's authority under Hawaii Revised Statutes Chapter 127A, all persons entering the State of Hawai'i are subject to mandatory self-quarantine unless otherwise exempted. The purpose of this Order is to define the activities that may be performed by exempt persons arriving into the state.

Except as indicated below, the Director of Emergency Management ("DEM") hereby orders and directs you to self-quarantine for a period of 14 days from the time of your entry into the State, or the duration of your stay in the State whichever is shorter. During the 14-day period, you may break self-quarantine solely to conduct the activities as described in the paragraphs below.

• You are an employee of the United States Government in Hawaii for official business. During your stay in Hawaii, you are not subject to any of the Governor's emergency proclamations related to the COVID-19 Emergency nor the DEM order, but shall follow all rules, regulations, and requirements set forth by your federal agency with respect to COVID-19 related safety protocols.

• You are exempt as a federal critical infrastructure sector worker as set forth in Exhibit B to the Governor's Tenth Proclamation Related to the COVID-19 Emergency, as such exhibit may be amended by CISA. You may break self-quarantine for the sole purpose of: (a) traveling directly from your self-quarantine location to your place of work, (b) performing your critical infrastructure sector work; and (c) traveling directly back to your self-quarantine location. The terms and conditions of the e-mail issued to you by <u>covidexemption@hawaii.gov</u> are hereby incorporated into the terms of this Order. If you do <u>not</u> have an email issued by <u>covidexemption@hawaii.gov</u> you are strictly limited to (a), (b), and (c) herein.

• You are exempt for compassionate or medical reasons to conduct the activities as allowed in the email issued to you by <u>covidexemption@hawaii.gov</u>. The terms and conditions of the <u>covidexemption@hawaii.gov</u> e-mail are hereby incorporated into the terms of this Order.

• You are exempt pursuant to separate order by the DEM. The terms and conditions of the exemption notice you received from the DEM, or from an entity authorized by the DEM to issue an exemption are hereby incorporated into the terms of this Order.

You must carry a copy of this order and any of the other documents incorporated and referenced herein at all times.

All persons must wear appropriate protective gear and practice safe practices as set forth in the most current Governor's Emergency Proclamation Related to the COVID-19 Emergency.

The knowing and intentional failure to follow any part of this Order constitutes a criminal offense punishable by a fine of not more than \$5,000, or imprisonment of not more than one year, or both.
