

**NOTICE OF SALE AND DISPOSITION
OF 68'6" STEEL HULL FISHING VESSEL; PACIFICA
BY PUBLIC COMPETITIVE SEALED BIDS**

Notice is hereby given that a 68'6" steel hull fishing vessel named "Pacifica" is being offered for sale by the HAWAII DEPARTMENT OF TRANSPORTATION (DOT), HARBORS DIVISION. Pursuant to Hawaii Administrative Rule 19-42-58, the vessel will be sold by competitive bid sale. **The vessel reserve bid will start at \$16,000.** Interested buyers may inspect the vessel and its contents at their own risk on (November 27, 2018) at 9:00 AM at Pier 12.

Bids must be emailed (leeann.k.kaili@hawaii.gov) or (keith.k.kamahele@hawaii.gov) or delivered in-person to DOT Harbors Oahu District, 700 Fort Street, Pier 11 Gallery Honolulu HI, 96813, no later than December 7, 2018 at 3:30 PM. Emailed bids must be sent as a protected word attachment with the password sent in a follow-on email. Hand-carried bids must be in a sealed envelope with return name, telephone number and address to identify bidder. Public announcement of the bids will be made on December 11, 2018 at 11:00 AM in the Oahu District Conference Room, 700 Fort Street, Pier 11 Gallery, Honolulu Hawaii 96813.

The subject vessel shall be sold as-is, where-is with no warranties expressed or implied. It is the buyer's responsibility to remove the items within the stipulated time after purchase; no guarantees or warranties are given by the State for the items; major defects, if known, are listed, but the State makes no claim that all defects are known; no sale will be invalid if defects are discovered in the item after the sale; and the State assumes no responsibility or liability once the items are sold.

The sale shall be made in accordance with the provisions of the notice of a bid sale to the highest **responsive and responsible bidder**, provided that the price offered by such bidder is acceptable to the State. If the State determines the bid is not advantageous to the State, the State may reject the bids in whole or in part and may re-solicit bids or may negotiate the sale, provided that the negotiated sale price is higher than the highest responsive and responsible bidder.

Interested parties are informed of the requirement for the purchaser to remove the vessel from its present location at Pier 12, Honolulu Harbor, at sole cost and risk to buyer, within **fourteen (14) calendar days** after the issuance of the Bill of Sale. The sale includes the subject vessel plus any contents and fixtures which are on the boat. Successful bidder must have a minimum amount of cash, certified check or bank check (U.S. Banks) for amount of bid on-hand and payable at the time of the opening of sealed bids or as notified by seller of winning bid if not present. Checks should be payable to the "Department of Transportation – Harbors Division Special Fund" and delivered to Oahu District, 700 Fort Street, Pier 11 Gallery Honolulu HI, 96813.

Failure to remove vessel by deadline will result in cancellation of sale. DOT will retain any payment as liquidated damages. In the event successful bidder fails to remove vessel by deadline, DOT may—at its discretion—offer the sale to the next highest bidder in descending order of bid. Successor purchase will be subject to the same terms, conditions and deadlines as original high bidder.

DOT reserves the right to cancel the sale or remove any item from the sale. The stated item is under the custody of the DOT. Trespassing is prohibited.

If the vessel is not sold by bid sale, it may be otherwise sold or disposed of in accordance with Hawaii Administrative Rule 3-130.
