

MOTORCYCLE OFF-STREET SKILLS TEST INSTRUCTIONS

(MAY BE CANCELLED DUE TO INCLEMENT WEATHER, SAFETY CONCERNS, AND UNFORESEEN EMERGENCIES WITHOUT NOTICE)

SIGN UP FOR TESTING

- Time: 8:00 a.m.—8:45 a.m., Tuesdays and Thursdays only, except holidays
- Fee: \$8.00
- Walk-in basis only

REQUIREMENTS

- Valid Hawaii Type 1 (moped) or Type 2 (motorcycle/motorscooter) permit.
- Original current Certificate of Registration (temporary dealer registrations are not acceptable.)
- Current Hawaii No-Fault insurance identification card in accordance with Section 431:10C-107, Hawaii Revised Statutes. **NOTE: the name(s) on the insurance card must be the same as shown on the certificate of registration.**
- Current Hawaii vehicle inspection certificate and inspection decal affixed on the vehicle.
- Rental vehicles must have the original certificate of registration, current vehicle inspection certificate and Hawaii No-Fault insurance card. The applicant's name must be listed on the rental contract.
- New vehicles must have the 1) original sales contract; 2) current temporary license plate issued by the dealer attached to the vehicle; 3) current vehicle inspection certificate; and 4) Hawaii No-Fault insurance identification card.
- Department of Transportation approved helmet with eye protection, long sleeved shirt/jacket, long slacks/pants and covered shoes must be worn.

TEST SITE: NO PRACTICING ALLOWED ON THE COURSE

- Location: 897 2nd Street—Pearl City CDL Office
- NOTE: Do not enter the test site until directed by the examiner. Park on the street along the fence line.**
- Testing : Begins promptly at 9:00 a.m.
 - Prior to conducting the skills test, the vehicle must pass a preliminary equipment inspection which will be conducted by the examiner.

COMPLETION OF SKILLS TEST

PASS: Return to the CDL Office with the following:

- Instruction Permit
- Test Score Sheet
- Hawaii Driver License, if applicable
- Legal presence documents if not previously submitted (Original birth certificate or valid U.S. Passport, Social Security Card, Principle Residence etc.) Please visit www.license.honolulu.gov for acceptable documents.

FAIL: Must wait at least seven (7) days before being eligible for another test.

NOTE: Types 1 and 2 permits cannot be renewed unless the off-street skills test is attempted prior to the expiration date of the permit. If the permit expires without attempting the off-street skills test, a three (3) month waiting period is mandatory before being eligible to reapply for a new Type 1 or Type 2 permit.
