II. Old Business

- a. The Committee approved the Draft Annual Report to the 2026 Legislature, allowing for non-substantive updates and edits, as provided by the Committee members by 2/4/2026. Once finalized, the report will be transmitted to the Hawai'i Department of Transportation for submission on behalf of the Safe Routes to School Advisory Committee.
- b. The Committee approved the dispersal of Safe Routes to School special fund monies to cover the 5% central services charge incurred by Hawai'i Department of Transportation (HDOT) every fiscal year, as required under HRS 36-27. The Committee amended the original action to ensure it did not have to address this issue annually, as well ensuring it applied to charges incurred, not estimated or forecasted.
- c. **Update on SRTS Special Fund Status:** This will be a new standing agenda item to provide regular visibility into the fund's balance, revenue and expenditures.
 - The current FY26 budget authority is \$13,048,280.
 - The current amount in SRTS Special Fund was \$10,707,974.65.
 - Planned allotment by quarter (FY26):
 - Q1 (July - Sept 2025) – \$8,679
 - Q2 (Oct - Dec 2025) – \$6,024,739
 - Q3 (Jan - Mar 2026) – \$4,024,739
 - Q4 (Apr - June 2026) - \$3,024,742

HDOT transferred \$2 million to the County of Kaua'i for their recommended projects and established a \$100,000 charge code for the recommended HDOT project. The other counties transfers are forthcoming. It was requested that the report include spending/disbursement to this presentation as well.

In addition, Chair Seitz asked for an update on the new vehicle registration fee dedicated to the SRTS special fund regarding implementation dates by county and when revenues would begin depositing into the fund. HDOT has not received notification from the counties regarding implementation dates.

III. Presentation - Mililani And Kekaulike HIDOE Carpool Program by Kimberlee Cadell and Felice Wilson, GoKid Corporation

During the meeting, GoKid Corporation provided a presentation on their Hawai'i Department of Education (DOE) carpooling pilot and its alignment with the SRTS program and goals. Launched in August 2025 at 14 schools in the Mililani (O'ahu) and Kekaulike (Maui) complex areas, the program has over 300 registered families and is designed to reduce single-occupancy vehicle

trips, supplement limited bus service, and ultimately make walking and biking safer around schools.

The presenters described outreach efforts including emails, webinars, school newsletters, banners, yard signs, and in-person events such as open houses and a community talk story. The presenters also explained that the platform’s parent-to-parent tools and chat can also be used to organize walking and biking groups, not just vehicle carpools. GoKid and HIDOE shared survey results from 76 schools (and 185 parents) showing widespread concerns about traffic and safety, strong interest in a carpooling solution (50 schools indicated interest), and very low current rates of carpooling. The presenters also signaled that HIDOE is exploring expanding the pilot into a broader program via an RFP process. As such, GoKid is interested in deeper coordination with the SRTS Advisory Committee.

IV. New Business

Due to limited time, Chair Seitz deferred several agenda items to the February meeting, including an update to the plan and program RFQ update and an update regarding HDOT’s SRTS coordinator funding request. However, Chair Seitz requested an update on the documentation needed for the County of Hawai’i SRTS staff funding request. Tara Lucas from HDOT said it may be completed within a month but they could not commit firmly as it was an FY27 priority. In addition, updates were provided regarding other counties’ money dispersal for recommended projects. HDOT is developing a standard IGA template for the counties that are required by the County of Hawai’i, County of Maui, and City & County of Honolulu.

Chair Seitz announced future speakers for February 24, 2026 - Erin Oswald, recommended by several committee members, who had presented at the Safe Routes to School National Online Forum in October 2025.
