



HANA HIGHWAY BRIDGE IMPROVEMENTS

The Hawaii Department of Transportation (HDOT), in partnership with the Federal Highway Administration, Central Federal Lands Highway Division (FHWA-CFLHD),

will be holding public meetings to discuss a project to improve six of the historic bridges along the Hana Highway (Route 360) located between Huelo and Hana town in east Maui. This meeting is the second in a series of public meetings, as a follow-up to the meetings held in the spring of 2019. The bridges include **Kailua Stream Bridge** (Mile Post [MP] 5.9), **Makanali Stream Bridge** (MP 8.2), **Puohokamoa Stream Bridge** (MP 11.0), **Kopiliula Stream Bridge** (MP 21.7), **Ulaino Stream Bridge** (MP 27.9), and **Mokulehua Stream Bridge** (MP 28.3). The project would improve these six bridges in a context-sensitive manner so they are safe and functional for highway users. Overarching goals for the project were developed through an earlier planning process for all bridges on the route. The six bridges now being studied in more detail have been identified by HDOT as high priority for improvements.
