#### Annual report to the Hawaii Legislature on bikeway projects and expenditures

#### Introduction:

Section 264-18 Hawaii Revised Statutes requires the Department of Transportation to report annually on their bikeway projects and expenditures. In addition, at least two percent of eligible federal funds shall be expended for bikeway projects.

There are three basic types of bicycle facilities: shared use paths, bicycle lanes, and signed shared roadways. Shared use paths are facilities for bicyclists and pedestrians that are separated from the motor vehicle roadway. They are intended for use by non-motorized vehicles with the exception of emergency vehicles, maintenance vehicles, and motorized wheelchairs. Bicycle lanes designate a section of roadway for use by bicyclists through signage, striping, pavement markings, and/or additional treatments. Signed shared roadways are a street or highway designated as a preferred bicycle route where bicyclists share the motor vehicle lane or travel on the shoulder.

#### Bikeway Projects and Expenditures:

A summary of bikeway projects and expenditures is illustrated below in Table 1: Bikeway Projects and Expenditures. The amounts shown are federal and state funds obligated in Federal Fiscal Year 2021 (October 2020 - September 2021) for projects that had expenditures in Federal Fiscal Year 2022 (October 2021 – September 2022). Table 1 lists bikeway projects that include 16.7 miles of new or improved bicycle facilities.

On the island of Kaua'i, the Lydgate Park to Kapa'a Bicycle and Pedestrian Path Phase D project is part of a proposed 20-mile Līhu'e to Anahola coastal shared use path (Ke Ala Hele Makalae). Construction activities continue for these projects. The Lydgate Park to Kapa'a phase D is from Papaloa Road near the Coconut Marketplace to the bridge crossing Uhelekawawa Canal at Kuhio Highway. An additional section, yet to be developed, is the Keālia to Anahola section. The path includes 8.3 miles that have been completed in previous years. The Kawaihau Road, Hau'a'ala Road, Mailihuna Road Complete Street & Safety Improvements project is constructing paved shoulders for bicycle use. The Po'ipū Road Multimodal Improvements project is constructing new bicycle lanes and buffered bicycle lanes. The Puhi Road Rehabilitation Phase 2 project is constructing new bicycle lanes. Planning is underway for additional bikeway improvements on Kaua'i.

On the island of O'ahu, the planning and design phases continue for the Ala Wai Bridge Project,

which will be a bicycle and pedestrian bridge across the Ala Wai Canal between Waikīkī and McCully-Mōʻiliʻili neighborhoods. This bridge will provide an additional crossing for people walking and bicycling over the Ala Wai Canal to connect to schools, shopping, and other daily destinations.

On the island of O'ahu, the Hawai'i DOT started construction on the Ala Moana Boulevard Elevated Pedestrian Walkway project. The safety project involves building a mauka-makaioriented "land bridge" that will link to paths on either side of Ala Moana Boulevard. The project has been awarded a \$20 million BUILD grant from the Federal Highway Administration and is a partnership between HDOT and Victoria Ward Limited (developer for the 60-acre master planned Ward Village). The Leeward Bikeway continues work on the planning and construction phases. The Leeward Bikeway will be a 10-foot-wide shared use path with a 2-foot buffer on each side of the path. This phase includes two bridges near Waipahu Depot Street. This phase of the Leeward Bikeway includes 3.3 miles of a new shared use path between Waipahu Depot Street to Philippine Sea Road. The Kalaniana' ole Highway Improvements project includes 1.5 miles of a new shared use path and repaying the existing section of the signed shared road bicycle route. The Nimitz Highway and Ala Moana Boulevard resurfacing project includes repaying the existing bike lane on Nimitz Highway. The Kamehameha Highway Rehabilitation project includes repaving, striping, and installing new curb delineators for the section of the shared use path that is next to the highway. The Kahekili Highway pavement preservation project includes repaying and restriping the existing bike lane. The replacement of bridges 3 and 3A in Mākaha on Farrington Highway include widening the shoulder space for bicycle use on this existing signed shared road bicycle facility. The replacement of the Maipalaoa Bridge on Farrington Highway includes improving the shoulder space for bicycle use on the existing signed shared road bicycle facility. Two federally-funded non-infrastructure activities that included bicycles are the State of Hawai'i Advanced Crash Analysis and the National Summer Transportation Institute Program. The replacement of the Kaipapa'u Stream bridge on Kamehameha Highway includes a new wide shoulder space and a separate walkway. This improvement will benefit bicyclists, but this bridge project is not included in the federal expenditures list because this area is not a signed bicycle route.

On the island of Maui, the County's Onehe'e Avenue Roadway Improvements project included separated bicycle lanes, signage, and green bicycle lane crossings at the intersections. The County's S. Kihei Road Rehabilitation project included pavement rehabilitation/reconstruction of bicycle lanes, markings, and signage. For the Hawaii DOT, the Kahekili Highway Resurfacing project included repaving an existing section of shoulder bikeway. Planning is underway for additional bikeway improvements on Maui.

On the island of Hawai'i, the County's Hilo Bayfront Trails Phase II project is in the process of starting construction. The Phase II project is a 12-foot shared use path that includes a path along Waiolama canal, a path section around the parking area, and a path connection from the handicapped parking to the trail. Hilo Bayfront Trails provides safe access as an off-street transportation facility for bicyclists and pedestrians to access the farmer's market, Mo'oheau Bandstand, Hilo Bayfront Beach Park, Banyan Drive hotels, Lili'uokalani Garden, the Port of Hilo, and other destinations along the bayfront area. The County of Hawai'i (in coordination with PATH) are working to expand the Hawai'i Island Bikeshare in the Kona and Hilo Districts. Planning is underway for additional bikeway improvements on Hawai'i island.

As noted in Table 1: Bikeway Projects and Expenditures, \$36,642,634 of federal funds were allocated to establishing bikeways statewide. This accounts for 20.2% of federal money eligible for bikeway expenditures. The Hawai'i Department of Transportation exceeds the requirement of spending two percent of federal eligible funds on bikeway projects.
